### **RESTAURANT REVIEW: VIA SOFIA'S ITALIAN KITCHEN**

Remember the Zio Johnno's across from Coe College on First Avenue? I am sure that several members of the bar would stop there (including me), and carry out various Italian dishes that were consistently good meals and reasonably priced. Then the restaurant closed and for many months (maybe years) it seemed that the building was being renovated.

The renovation has now been completed and it has been opened as Via Sofia's Italian Kitchen. I decided to check it out. I discovered that this restaurant is the same as the old Zio Johnno's and is different than the old Zio Johnno's. Now you might say how can it be the same and be different at the same time?

This is the reason it is the same. The menu includes spaghetti, mostaccioli, tortellini, stuffed ravioli, fettuccine alfredo, chicken alfredo, baked manicotti, baked lasagna and chicken parmesan. They also have a carry out special that includes a ½ gallon of spaghetti and meat sauce, 16 inch loaf of garlic bread and a ½ gallon of tossed salad. I tried the baked lasagna with the meat sauce. It also included six slices of garlic bread served toasted. It was good. Tasty, plentiful, properly cooked and timely served. And the price was right. Classic Zio Johnno's.

This is the reason it is different. The menu includes breakfast items like cinnamon rolls and various coffee and tea drinks, hot and cold sub sandwiches, several different types of salads and even desserts. My wife had the chicken salad that included black olives, tomatoes, and mozzarella cheese on a bed of fresh crunchy lettuce with ranch dressing on the side. The sliced, white meat, chicken was placed on top of the salad and was plentiful. In my wife's own words, "it was nothing to write the pope about".

See what I mean? It is the same and it is different. Same quality. Same quantity. Same price. Different menu. Different decorating. Cinnamon rolls?

Next week we are going to try breakfast at Sofia's. Our friends tell us we will like it. Maybe it will be more of the same or maybe it will be different.
