ARTICLES OF CORRECTION

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 115 of the Revised Iowa Nonprofit Corporation Act, the undersigned corporation adopts and files the following Articles of Correction:

1. The name of the corporation is:

Linn County Bar Association.

2. A description of the document to be corrected is as follows:

Articles of Amendment to Restated Articles of Incorporation.

3. The document to be corrected was filed by the Secretary of State on:

September 22, 1993.

4. The incorrect statement in the document to be corrected is item 2:

The Articles of Incorporation are hereby amended by deleting Article III and substituting therefore the following:

ARTICLE III  
MEMBERSHIP, DUES AND ASSESSMENTS

Any person of good character and reputation who has graduated from an accredited law school, who works or who resides in Linn County, who pays dues and assessments, if any, which are fixed from time to time by the Board of Governors, and who complies with such conditions as may be required by the Articles or the Bylaws, shall be eligible for membership upon election by majority vote of the members present at any annual, regular or special meeting of the corporation.

The Board of Governors shall have the power and authority to fix the dues and assessments, if any, to be paid by members. Such dues and assessments may vary among classes of members if the Board of Governors from time to time elects to vary dues and assessments taking into account a member's status as honorary, inactive, retired or the like. The Board of Governors may, after it has established classes of membership, vary those classes, adopt additional classes, or eliminate classes as the Board may elect.

5. The reason that the document is incorrect is as follows:

The Articles of Amendment to Restated Articles of Incorporation provide that Article III is to be deleted when Article VIII is the article that should be deleted.

6. The corrected statement or corrected execution of the document is as follows:

The Articles of Incorporation are hereby amended by deleting Article VIII and substituting therefor the following:

ARTICLE VIII  
MEMBERSHIP, DUES AND ASSESSMENTS

Any person of good character and reputation who has graduated from an accredited law school, who works or who resides in Linn County, who pays dues and assessments, if any, which are fixed from time to time by the Board of Governors, and who complies with such conditions as may be required by the Articles or the Bylaws, shall be eligible for membership upon election by majority vote of the members present at any annual, regular or special meeting of the corporation.

The Board of Governors shall have the power and authority to fix the dues and assessments, if any, to be paid by members. Such dues and assessments may vary among classes of members if the Board of Governors from time to time elects to vary dues and assessments taking into account a member's status as honorary, inactive, retired or the like. The Board of Governors may, after it has established classes of membership, vary those classes, adopt additional classes, or eliminate classes as the Board may elect.
